- Secretary Ministry of Electronics & Information Technology (MeitY) & Chairman NIXI today inaugurated three path breaking initiatives for National Internet Exchange of India (NIXI). With this launch, NIXI has announced to play a supporting role for the IPv6 awareness and adoption in the country along with DOT & MeitY.
- ➤ IPv6 Expert Panel (IP Guru) (https://nixi.in):
- ▶ IP Guru is a group to extend support to all the Indian entities who are finding it technically challenging to migrate and adopt IPv6. In addition to this the IPv6 expert group will help in identifying & hiring agency that will help end customer by providing necessary technical support to adopt IPv6. This panel will guide all such Indian entities and help in increasing the IPv6 adoption. It's a joint effort of DOT, MeitY & community to promote IPv6. The expert panel group comprises members from government and private organizations.
- NIXI Academy (https://training.nixi.in):
- NIXI Academy is created to educate technical/non-technical people in India to learn and relearn technologies like IPv6 which are normally not taught in Educational Institutes. The easy-to-use platform helps network operators and educators understand networking best practices, principles and techniques; manage Internet resources better; and use appropriate Internet technologies more effectively. NIXI academy comprises an IPv6 training portal which is developed with the help of various technical experts in order to provide mass training to the community. Through this academy our Internet community will be able to learn from various technical modules. Successful candidates (after passing examination) can take a certificate from NIXI, which will be useful to find/upgrade jobs in the Industry.
- NIXI-IP-INDEX (https://ipv6.nixi.in):
- NIXI has developed an IPv6 index portal for the Internet community. NIXI-IP-INDEX portal will showcase the IPv6 adoption rate in India and across the world. It can be used to compare IPv6 Indian adoption rate with other economies in the world. NIXI will populate this portal with web adoption in IPv6, IPv6 traffic etc. in coming days. This portal will motivate organisations to adopt IPv6, provide inputs for planning by technical organisations and research by academicians.

2. National Startup Advisory Council



- Minister of Railways, Commerce & Industry, Consumer Affairs and Food & Public Distribution Shri Piyush Goyal today chaired the first meeting of National Startup Advisory Council(NSAC).
- Department for Promotion of Industry and Internal Trade (DPIIT) had constituted the National Startup Advisory Council to advise the Government on measures needed to build a strong ecosystem for nurturing innovation and startups in the country to drive sustainable economic growth and generate large scale employment opportunities.
- Besides the ex-officio members, the council has a number of non-official members, representing various stakeholders such as founders of successful startups, veterans who have grown and scaled companies in India, persons capable of representing interest of investors into startups, persons capable of representing interests of incubators and accelerators, representatives of associations of stakeholders of startups and representatives of industry associations.
- it is our collective responsibility to realise the objectives of 'Startup India: The Way Ahead', which was launched by the Prime Minister in January this year. this will help India reach a stage, where countries around the world would look to model their own startup ecosystems based on India's achievements and will take 'StartUp India' to the Global Stage.

3. Empowered Group 2 (EG2)



- A meeting of Empowered Group 2 (EG2) was held to review the availability of essential medical equipment and oxygen during COVID.
- the 12 states with high burden of active COVID cases viz.— Maharashtra, Madhya Pradesh, Gujarat, Uttar Pradesh, Delhi, Chhattisgarh, Karnataka, Kerala, Tamil Nadu, Punjab, Haryana and Rajasthan. While the demand in Maharashtra expected to beyond available production capacity of the state, states like Madhya Pradesh do not have any production capacity to meet their demand for medical oxygen. Besides, there is a trend of increasing demand in other oxygen producing states such as Gujarat, Karnataka, Rajasthan,
- To give clarity and assurance to the states on oxygen supplied over the next few weeks of surge in cases, a mapping exercise was undertaken jointly by DPIIT, MOHFW, Ministry of Steel, various critically affected states, Petroleum and Explosives Safety Organisation (PESO) along with key stakeholders including the representatives from oxygen manufacturers, All India Industrial Gas Manufacturers Association (AIIGMA) as per the directions of Empowered Group -2 (EG2). Sources of medical oxygen and their production capacity was mapped to match the requirement of states and an indicative framework has been developed to guide the states on the sources of medical oxygen.
- Accordingly, 4880 MT, 5619 MT and 6593 MT have been indicated to these 12 states for meeting their projected demand as on 20th April, 25th April and 30th April, respectively. MOHFW is issuing orders in this regard and the same would be notified by MHA.
- EG2 directed MOHFW to identify another 100 hospitals in far flung locations for consideration of sanction for installation of PSA plants.
- Import of 50,000 MT of medical oxygen: In view of increasing demand for medical oxygen, EG2 decided to float a tender for import of 50,000 MT of medical oxygen. MOHFW has been directed to finalise the tender for the same and also explore possible sources for import identified by the missions of MEA.
- EG2 is monitoring the situation of demand and supply of medical oxygen continuously to ensure that all necessary steps are taken to support the uninterrupted supply of medical oxygen.

4. Kohli is Wisden's ODI player of 2010s



- Virat Kohli has been named Wisden Almanack's ODI player of the 2010s, while England all-rounder Ben Stokes was declared the 'Cricketer of the Year' for a second successive time.
- ➤ Kohli, who made his ODI debut in 2008 and was part of the 2011 World Cup-winning Indian team, made more than 11,000 runs in the 10-year stretch, averaging over 60 and scoring 42 centuries.
- Sachin Tendulkar was named the ODI Cricketer of the 1990s and Kapil Dev the best for the 1980s.

5. Gaganyaan mission



- Space agencies of India and France signed an agreement for cooperation for the country's first human space mission Gaganyaan.
- ➤ The agreement was announced during French Foreign Affairs minister Jean-Yves Le Drian visit to the Indian Space Research Organisation's (ISRO) headquarters.
- ISRO has asked CNES to help prepare for Gaganyaan missions and to serve as its single European contact in this domain.
- Under the terms of the agreement, CNES will train India's flight physicians and CAPCOM mission control teams in France at the CADMOS centre for the development of microgravity applications and space operations at CNES in Toulouse and at the European Astronaut Centre (EAC) in Cologne, Germany
- The agreement provides for the CNES to support implementation of a scientific experiment plan on validation missions, exchange information on food packaging and the nutrition programme, and

above all the use by Indian astronauts of French equipment, consumables and medical instruments.

- French equipment developed by CNES, tested and still operating aboard the International Space Station (ISS) will thus be made available to Indian crews.
- The CNES will also be supplying fireproof carry bags made in France to shield equipment from shocks and radiation
- The Gaganyaan orbital spacecraft project was kicked off in August 2018. It originally intended to send astronauts from Indian soil to mark the 75th anniversary of India's independence in 2022.

6. e-visa for 156 countries.



The Ministry of Home Affairs (MHA) has restored electronic visa (e-visa) facility for foreigners from 156 countries, who intend to visit India for the purposes of business, conferences, and for medical reasons, including in the case of medical attendants. E-visa for tourists is yet to be restored.


Though the facility is available to 171 countries, after restrictions were announced in 2020, it has been restored only for 156 countries. China, the U.K., Canada, Hong Kong, Indonesia, Iran, Malaysia and Saudi Arabia are notable exclusions.

India had earlier relaxed visa restrictions on October 22, 2020 enabling foreigners to come to India for business, conferences, employment, education, research and medical purposes, after availing regular visas from missions and embassies abroad.

An e-visa is provided in five categories — tourist, business, conference, medical, and medical attendant.

Under the arrangement, a foreigner can apply online (https://indianvisaonline.gov.in/) four days prior to travel. After the details are verified, an electronic travel authorisation (ETA) is generated, which has to be presented at the immigration checkpost on arrival. Entry through e-visas is allowed only at 28 designated international airports and 5 major seaports in India.

7. UNFPA's population report 2021



Nearly half the women from 57 developing countries do not have the right to make decisions regarding their bodies, including using contraception, seeking healthcare or even on their sexuality, according to the United Nations Population Fund's (UNFPA) flagship State of World Population Report 2021 titled 'My Body is My Own' launched.

This is the first time a United Nations report has focused on bodily autonomy, defined as the power and agency to make choices about your body without fear of violence or having someone else decide for you.

- The report shows that in countries where data is available, only 55% of women are fully empowered to make choices over healthcare, contraception and the ability to say yes or no to sex. It also highlights that only 75% of countries legally ensure full and equal access to contraception.
- Some examples of violation of bodily autonomy include, child marriage, female genital mutilation, a lack of contraceptive choices leading to unplanned pregnancy, unwanted sex exchanged for a home and food or when people with diverse sexual orientations and gender identities cannot walk down a street without fearing assault or humiliation. Under its ambit also fall people with disabilities stripped of their rights to self-determination, to be free from violence and to enjoy a safe and satisfying sexual life.
- Women around the world are denied the fundamental right of bodily autonomy with the COVID-19 pandemic further exacerbating this situation... Realising bodily autonomy is essential to achieving the UNFPA's goals of ending the global unmet need for contraception, preventable maternal deaths, gender-based violence and harmful practices by 2030.
- In India, according to NFHS-4 (2015-2016), only about 12% of currently married women (15-49 years of age) independently make decisions about their own healthcare, while 63% decide in consultation with their spouse. For a quarter of women (23%), it is the spouse that mainly takes decisions about healthcare. Only 8% of currently married women (15-49 years) take decisions on the use of contraception independently, while 83% decide jointly with their spouse. Information provided to women about use of contraception is also limited only 47% women using a contraceptive were informed about the side effects of the method, and 54% women were provided information about other contraceptives.

Women's access to bodily autonomy is measured in the report through their power to make their own decisions about their reproductive health care, contraceptive use and sexual relations and the extent to which the laws of the countries support or interfere with a woman's right to make these decisions.

8. Annuity clause goes for NPS subscribers

Positive returns

Excerpts from the reforms announced for subscribers:

- Soon, NPS savings upto ₹5 Lakh can be withdrawn entirely at retirement
- For those with higher savings, the mandate to annuitise 40% of the corpus is being reviewed
- Members can opt to retain 40% of the corpus in NPS and withdraw over 15 years
- Decisions taken as low annuity rates and high inflation translated into negative returns for pensioners



- The National Pension System (NPS) will no longer compel investors to convert 40% of their accumulated retirement corpus into an annuity, as poor yields on annuities and high inflation are translating into negative returns, the Pension Fund Regulatory and Development Authority (PFRDA) Chairman, Supratim Bandyopadhyay, said.
- > The regulator will issue fresh rules to soon allow those saving up to Rs. 5 lakh in the NPS to take the whole amount at retirement, up from Rs. 2 lakh at present. The pension fund regulator is also hoping to launch the first guaranteed return NPS scheme in the coming year
- ➤ Separately, amendments will be made to the PFRDA Act of 2013 to allow NPS members with a balance over ₹5 lakh to retain 40% of the corpus in the NPS or wind it down over a few years through a system akin to a systematic withdrawal plan.
- ➤ Post-retirement, a person has to take 40% of the total corpus as an annuity as per the law's mandate, and 60% can be commuted and taken as a lump sum. But the annuity rates always track the interest rates in the market which have come down drastically.
- > The Finance Ministry has announced plans to amend the PFRDA law since Budget 2019-20 and to make legislative changes to override the statutory annuitisation provision.
 - 9. Janagosthiya Samannay Parishad, Assam (JSPA)



- The Janagosthiya Samannay Parishad, Assam (JSPA) launched a portal for conducting the first-ever census of Assamese Muslims for distinguishing them from their migrant, Bengal-origin or Bengalispeaking counterparts.
- The JSPA represents three categories of Assamese Muslims Goriya who converted from various indigenous groups and tribes, Moriya whose ancestors were brought by the Ahom kings to make weapons and utensils and Deshi who converted specifically from the Koch-Rajbongshi community.
- The three-month exercise, seen as a small-scale version of the National Register of Citizens (NRC), has a cut-off period corresponding with the British annexation of Assam in the early 1800s. The JSPA considers the pre-British rule Muslims of Assam as indigenous, which is why the Jolahas converts from among tea plantation workers who were brought from central India by British planters have been kept out of the census.
- Released in August 2019, the NRC had excluded 19.06 lakh of 3.3 crore applicants for lack of documents establishing them as the citizens of India. The cut-off period for the NRC was March 24, 1971, as prescribed by the Assam Accord of 1985 for detecting and deporting foreigners or "illegal immigrants.
- We launched the portal jspacensus.com portal April 15 to coincide with the Assamese New Year and hope to complete the exercise by the end of 2021," JSPA's chief convenor Syed Mominul Aowal said.
- The portal also lists 17 organisations recognised or empanelled with the JSPA and their phone numbers to be contacted for any issues with registering online. These organisations include Desi Janagostiyo Manch, Assam, Axomiya Muslim Kalyan Parishad, Khilonjiya Axomiya Musolman Unnayan Parishad and Hodow Khilonjiya Muslim Oikyo Manch.
- This exercise was necessary as some migrant Muslims have undertaken an initiative to bring all Muslims living in Assam under one umbrella. Our religion and names may be the same but the indigenous Muslims have a distinct identity, given by the Ahom and Koch kings.
- According to the 2011 census, Muslims account for 34.22% of Assam's population. The JSPA claims Assam today has about 1.4 crore Muslims. of whom 40 lakh are indigenous Muslims.

10. Eatsmart Cities Challenge and Transport 4 All Challenge Launched.

- Shri Hardeep S Puri, MoS (I/C), Housing and Urban Affairs launched the EatSmart Cities Challenge and Transport 4 All Challengeat an online event
- The EatSmart Cities Challenge aims to motivate Smart Cities to develop a plan that supports a healthy, safe and sustainable food environment supported by institutional, physical, social, and economic infrastructure along with the application of 'smart' solutions to combat food related issues. The Transport4All Digital Innovation Challengeaims to develop digital solutions that will make public transport safe, affordable, comfortable, and reliable for all.
- > Transport 4 All (T4All) Challenge
- Indian cities have the golden opportunity to invest in public transport as a social good, completely revamp informal transit services, and prioritise digital innovation to improve user experience. The Ministry of Housing and Urban Affairs launched the Transport 4 All challenge in collaboration with ITDP. The Challenge aims to bring together cities, citizen groups, and start-ups to develop solutions that improve public transport to better serve the needs of all citizens.
- At the core of the Challenge are citizens who will not only define the problems for which solutions shall be created but also help start-ups and cities to refine the solutions to meet their needs. The first edition of the Challenge focuses on digital innovation. Cities and start-ups will receive guidance to develop and test various solutions, learn from them, and scale them to build people's trust in public transport and enhance their mobility. The solutions will make public transport—formal as well as informal— safe, convenient, and affordable for all. All the Smart Cities Mission cities, capitals of states and union territories (UTs), and all cities with a population of over 5 lakhs—are eligible for the Challenge.

Three Stages of the Challenge

The Transport4All through Digital Innovation Challenge comprises three stages:

- Stage I PROBLEM IDENTIFICATION: Cities, with the support of NGOs, identify key recurring problems that citizens and public transport operators face
- Stage II SOLUTION GENERATION: Start-ups develop prototypes of solutions to improve public transport with inputs from cities and NGOs
- Stage III PILOT TESTING: Cities engage start-ups for large-scale pilots and refine the solutions based on citizen feedback
