**1. CAG Girish Chandra Murmu selected as external** auditor of International Labor Organization



Comptroller and Auditor General of India, Girish Chandra Murmu has been selected as the External Auditor of International Labor Organization (ILO), Geneva for a period of four years (2024 to 2027). The CAG will take over from the current external auditor, the Supreme Audit Institution of the Philippines. Officials said the CAG's appointment is in recognition of his position among the international community as well as of his professionalism, high standards, global audit experience and strong national credentials. The ILO had constituted a selection panel and invited bids from the Supreme Audit Institutions (SAIs) for the appointment of the external auditor. Based on technical experience and other criteria, the ILO shortlisted three apex audit institutions (India, Canada and the UK) for technical presentations. In Geneva, a three-member team from India's CAG reviewed the ILO's Tripartite Select Panel on Strength, Presented approach and skill set as well as vast experience of auditing international organizations. Officials said the selection panel was influenced by the CAG's approach in developing a strategic partnership with the ILO, through which it aims to help the ILO meet its strategic goals while maintaining significant independence and oversight in performing the external auditor's functions. To help do. The panel specifically noted the relevance of the CAG's proposed use of data analytics, risk profiling and sampling in the audit process. The Comptroller and Auditor General of India is currently the external auditor of the World Health Organization (2020-2023), the Food and Agriculture Organization (2020-2025), the International Atomic Energy Agency (2022-2027), the Prohibition Organization chemical weapons (2021-2023), and the Inter-Parliamentary Union (2020–2022).

**2. ISSF in Egypt Two gold medals for India in shooting in the World Cup** 



India today won two gold medals in the World Cup Shooting Competition in Cairo, Egypt. India got this success in 10 meter air rifle mixed team and 10 meter air pistol mixed team event. India's team of Narmada Nitin Raju and Rudraksh Balasaheb Patil won the gold in the air rifle mixed team after defeating Hungary's Ester Dennis and Istvan Peni by 16 points to 6 points in the final. In the 10m air pistol mixed team event, India's Ridham Sangwan and Varun Tomar defeated Serbia's Zorana Arunovic and Demir Mikec by 10 to 16 points.

**3.** Federal Bank installs 100 KWp solar plant at Aluva office

Renowned Mohiniyattam dancer Kanaka Rele, who took classical dance to new heights in her eight-decade-long career, was remembered by her family and friends as a 'good-hearted woman'. The entire film industry is inconsolable due to his death. She started her journey in the field of dance at the age of seven. Raile was honored with other awards including Padma Shri (1989), Padma Bhushan (2013), Sangeet Natak Akademi Award (1994), Kalidas Samman (2006) and MS Subbulakshmi Award. #### 7. Mumbai's Churchgate railway station named after India's first RBI governor CD Deshmukh



It is related to the proposal to change the name of a famous place in Mumbai. This famous place is the Churchgate railway station of Mumbai. Maharashtra Chief Minister Eknath Shinde has passed a proposal to rename the historic Churchgate station as Chintaman Dwarkanath Deshmukh station. CD Deshmukh, a veteran economist, was born on 14 January 1896 in a Marathi family in Raigad district of Maharashtra. CD Deshmukh, who came to civil service after studying in England, became the first Indian governor of RBI in 1943 under the British Raj. Later, CD Deshmukh, who was the Union Finance Minister from 1950 to 1956, contributed

to the economic development of the country. The name Churchgate dates back to the British era. According to the information, in 1862 Sir Henry Bartle Frere became the Governor of Bombay. Taking the initiative to make Bombay city a mini London, he built many buildings and churches on the British theme in the area. At that time this entire area was surrounded by three gates. These gates were called Apollo Gate, Bazaar Gate and Church Gate. The way of Churchgate used to lead directly to St. Thomas Cathedral Church, hence the name of that gate was Churchgate.

### 8. Rudranksh Patil wins gold in 10m air rifle at ISSF World Cup 2023



India's Rudranksh Balasaheb Patil won the Men's 10m Air Rifle event at the ISSF World Cup 2023 in Cairo. He defeated Maximilian Ulbricht of Germany 16-8 in the gold medal match to win the top prize. Rudranksh Patil finished seventh in the qualification round with a score of 629.3 and made it to the ranking round where he topped the list with a score of 262.0. India's Tushar Shahu Mane finished second in the gualification round but could not participate in the ranking round as he was playing only for ranking points (RPO). Vidit Jain, another Indian competing for RPO, finished 15th in the qualification. This is Rudranksh Patil's second gold medal in the Cairo Shooting World Cup. He teamed up with Narmada Raju to win the gold medal in the 10m air rifle mixed team event. Meanwhile, Narmada Raju was competing in the women's 10m air rifle event but finished seventh. In this event, however, Indian medalist Tilottama Sen won the bronze medal after finishing third in the ranking round. Tilottama beat compatriot Ramita with 262.0 points to secure a podium position, just 0.2 more than her Indian teammate. Tilottama Sen 632 in the qualifying round. Ranked second with a score of 7. Ramita finished seventh while Narmada was the last shooter to qualify

for the ranking round. Former world number one Elavenil Valarivan and Nancy competed for the RPO in the qualifying round and finished eighth and 15th respectively. With these two medals, India continued to top the Cairo Shooting World Cup medals tally with five medals including three gold and two bronze. Hungary is in second place with gold and silver. Ranked eighth and 15th.
